**FIRE CONTROL ACT 2000 (NI)**  
**DECLARATION OF A FIRE DANGER PERIOD**  
**PUBLIC NOTICE**

The public are advised that I, Eric Russell Hutchinson, Administrator and delegate of the Commonwealth Minister under item 1.42 of the *Minister's Norfolk Island Delegation Instrument (No. 1) 2019* (CTH), **hereby declare** under section 21(1) of the *Fire Control Act 2000* [the Act] that a **fire danger period** applies to the whole of Norfolk Island **from midnight Friday 3 April 2020 until Friday 24 April 2020**.

During the particular period, all fires of any kind must first be approved by the Chief Fire Control Officer.

A person who otherwise lights a fire in the open air is guilty of an offence and may be fined up to \$2,000.00 or be imprisoned for two years or both.
