PROVISION OF FUEL FOR COUNCIL VEHICLES & EQUIPMENT

Norfolk Island Regional Council has 99 Diesel powered vehicles/equipment and 25 unleaded petrol vehicles. For the twelve months ending May 2022 Council purchased 82,000 litres of diesel and 21,000 litres of unleaded petrol to operate these vehicles and equipment.

Expressions of interest are invited by Council for the provision of both diesel and unleaded petrol for Council vehicles and equipment for a period of 12 months commencing 1 August 2022 (or as negotiated).
